The Board of Commissioners of the Parrish Fire District met in regular session on Tuesday, April 23, 2024, at 6:00 P.M. in the Commission Chamber.

Chairman Chitty opened the meeting of the Parrish Fire Commission.

The minutes of the previous meeting held March 26, 2024, were approved on a motion by Commissioner Webb, seconded by Commissioner Griesi, and carried by a vote of 4-0.

Chairman Chitty called for public comment. No one was present to speak.

Chairman Chitty opened the public hearing for Fire Assessments Rates public hearing, no one from the public signed up to speak. A motion was made to close the public hearing by Commissioner Griesi, seconded by Commissioner Stevens, and carried by a vote of 4-0. Commissioner Webb made a motion to approve Resolution 2024-01 with a 7.48% increase, seconded by Commissioner Stevens, and carried by a vote of 4-0.

Chief Bailey advised the board that Commissioner Eugene Hendry has asked to please accept this letter of resignation from his position on the board of Fire Commissioners due to personal reasons. Commissioner Griesi made a motion to accept Commissioner Eugene Hendry's resignation, seconded by Commissioner Stevens and carried by a vote of 4-0.

Chairman Chitty gave Chief Bailey directions to advertise the vacant position in the paper and have applications ready for review at the May 28th meeting. Commissioner Stevens made a motion to approve the legal ad for the vacant seat, seconded by Commissioner Webb and carried by a vote of 4-0.

The financial report for the month ending March 2024 was presented. Chief Bailey indicated that we have received most of the general fund revenue, \$3,746,671.26 with \$129,153.96 left to collect. Impact fee revenue is currently at \$284,317.85 with \$215,682.15 still left to collect. The financial report was approved on a motion by Commissioner Griesi, seconded by Commissioner Stevens and carried by a vote of 4-0.

In the administration report, Chief Bailey brought up many different items, and projects under way by Staff, & local events that everyone has covered.

Commissioners Reports

Commissioner Stevens – Asked how we are with getting Station 3 meetings set-up.

Commissioner Griesi – Advised everyone that all the hydrants in Forest Creek have been painted and also have no parking painted on the road in front of the hydrants. Great job keep up the good work!

Commissioner Webb – Also asked about Station 3.

Chairman Chitty – Thanked everyone for all their hard work! Good job to the crews that was at the fire, great knock down.

Commissioner Stevens motioned to adjourn the meeting, seconded by Commissioner Webb, and carried by a vote of 4-0. Meeting adjourned at 6:25 P.M.

^{*} The Fire Marshal may waive the fee for all publicly noticed fireworks displays which are printed prior to the display in a daily or weekly newspaper and/or a minimum of 3 days prior in an associated newspapers' website for the benefit of the general public which does not constitute an undue burden on the District. Per Florida Statute 791.08(1), private citizen displays not advertised as noted above would also be exempt from the fee on Independence Day (July 4th), New Years Eve (December 31st) and New Years Day (January 1st). Nothing herein exempts any person, municipality, or business from obtaining the proper authorization from the Fire Marshal prior to the display to the display of fireworks at any time.

RESOLUTION NO. 2024-02

A RESOLUTION OF THE PARRISH FIRE DISTRICT BOARD OF FIRE COMMISSIONERS, ADOPTING A USER SERVICE FEE SCHEDULE.

WHEREAS, the Parrish Fire District pursuant to the provisions of Chapter 191.006(11), F.S. has authority to charge user fees authorized by resolution of the Board, in amounts necessary to conduct district activities and services, and to enforce their receipt and collection in the manner prescribed by resolution and authorized by law; and

WHEREAS, the Parrish Fire District may provide for a reasonable schedule of charges for inspecting structures, plans, and equipment to determine compliance with fire safety codes and standards;

NOW THEREFORE BE IT RESOLVED by the Board of Fire Commissioners of the Parrish Fire District that a User Service Fee Schedule (Exhibit A) is hereby adopted and identified herein as Parrish Fire District User Service Fee Schedule, effective October 1, 2024.
